### Sales Contract / Health Guarantee

**Deposit:** The deposit to hold a puppy is \$200. A personal check may be used for **deposit only**. No puppy will be shipped until the remaining balance is paid in full (pymt method: cash, cashiers check, US Postal money order, PayPal Deposit Only (add 3%). The puppy is marked on the the web Deposit Pending, once a deposit has been received the puppy becomes unavailable to sell to any other party, therefore **DEPOSIT IS NOT REFUNDABLE**. In the event something should happen to the puppy deposit was placed on, buyer will be notified, and deposit is then **transferable** to one of similar price/sex/coat/color/pattern. The deposit is applied to the purchase price of the puppy. The puppy does need to be paid for in **full** at a minimum of 1 week prior to leaving breeders possession. **By purchasing or placing a deposit, purchaser agrees to the contract of JMK Mini Dachshunds and/or Kristal Couch (breeder/seller).**

This guarantee accrues to the benefit of the original purchaser only. It is not transferable and will become null and void if the puppy is sold, leased, in any other way transferred to a third party or if the puppy is no longer under the direct care, custody and control of the original buyer. There are no cash refunds, all sales are **Final**.

**You must have your new puppy examined by your vet within 3 days (72 hrs) of delivery to validate the health guarantee. This health guarantee is nullified and void if buyer does not follow through with vet exam within the 72 hrs of leaving breeders possession.**

**72 HOUR HEALTH GUARANTEE AGAINST DEATH DUE TO ILLNESS:** This dog is guaranteed to be in good health at the time of delivery. Replacement of puppy will be made if all of the following requirements are met:

1. The dog is declared to have a life threatening condition by a licensed veterinarian within 72 hours. The 72 hour period starts when the new owner receives the puppy. A written report submitted to Kristal Couch by the licensed veterinarian is required.
2. If puppy dies you must have followed all advice by your veterinarian and have an autopsy performed by your state medical laboratory. An autopsy report must be provided to Kristal Couch. If puppy is proven by a licensed vet to have a fatal defect, upon receipt of written confirmation from vet, puppy will be traded for a puppy of equal value, seller's choice.

The breeder/seller has taken proper precautions to prevent infectious disease, but is **not responsible** for any parasite, bacteria, or viruses that are not in the control of breeder/seller or buyer.

The breeder guarantees that this puppy is free of **genetic defects** (at breeder's discretion) that prevent this puppy from living a normal life as a pet for up to **12 months** after leaving the breeder's facilities.

The breeder does not guarantee against stress related illnesses. Information about Hypoglycemia is available from your local veterinarian. Buyer is aware that shipping a puppy can be stressful for the puppy. The puppy may vomit and aspirate some vomit.

**The seller is not responsible for any veterinary expenses.** All puppies are sold as pets, only for the buyer to enjoy. No guarantee will be given as to adult size, color, confirmation, trainability, or breeding ability. Our puppies are given all necessary shots and wormed regularly according to their age. Please give this form along with all other vaccination and worming records to your veterinarian on your first visit with your new puppy.

All puppies are sold on limited AKC registration, AKC papers will be provided once spay/neuter letter from your veterinarian has been provided. Full AKC registration may be available to approved breeders. The JMK kennel name has to appear in the registered name.

If for any reason buyer can no longer care for the puppy, buyer must return puppy to breeder (at buyer's expense) at any time for the life of the puppy without refund. This contract becomes void if puppy is sold to a third party.

Puppies are ready to leave at 8 to 9 weeks of age, so plan on having them paid in full at 6 to 7 weeks of age.

**Shipping** is available at buyer's expense. We ship using American Airlines, they have a climate controlled area for the animals, and they also fly to most anywhere. Shipping needs to be paid in full at least 1 week prior to estimated ship date. Our cost to ship a puppy is \$275, which includes the airline ticket, pet taxi, health papers, etc. required to ship a puppy. Seller is not responsible for shipping charges for any reason. If buyer fails to pick up puppy at designated shipping location, all monies paid toward said puppy will be lost.

**Delivery** is also available. We will drive to meet you, up to 150 miles from our home. If the distance is over that, we have to charge \$.50 per mile. If you are close enough to do this and would rather meet to get your new puppy, please let us know. We will do our best to work with you to make arrangements.



Each puppy will leave JMK Mini Dachshunds with a puppy pack. This pack will include, but is not limited to: sample puppy food, health record, registration papers, pedigree, new puppy owner tips, dachshund handout, toys, and a blanket.
